

## Claim ANCC CNE and CME Credits for Summit Sessions

### ➤ Quick Steps to Claim ANCC CNE and CME Credit

After attending your Summit sessions and viewing all applicable posters, follow these steps to claim your continuing education credits:

#### 1. Access the Portal via the website link or QR code

Visit <https://bit.ly/PDPS2026> (*not case sensitive*) or scan the on-site QR code to open the ANCC Credit Hour Portal.

#### 2. Locate Sessions

Browse Sessions or Search to find each session or poster you attended.

#### 3. Claim Credit

Select the session title, choose **Claim ANCC CNE Credit**, and complete the brief attestation and question.

#### 4. Download Certificate

Select **Review Claimed ANCC Credit Hours and Certificates** to download and save your certificate(s).

#### 5. Submission Deadline

All credit claims must be submitted by **Friday, May 22, 2026, at 12:00 PM (Noon) ET.**

*Late submissions will not be accepted.*

## Eligibility Requirements

- To earn ANCC CNE credit, attendees must:

### Attend qualifying educational sessions:

- **Earn 1 ANCC CNE and/or 1 CME** credit for each concurrent session block attended in full (each block may include one or more presentations).
- Attendees must attend the entire General Sessions on Days 2 and 3, which are **eligible for 1.5 ANCC CNE** credit.
- Earn **4 ANCC CNE** and/or **4 CME** credits by viewing all posters in the Summit poster area and submitting the attestation in the **ANCC Credit Hour Portal**.

**Maximum available:** 17.5 ANCC CNE credit hours and/or 17.5 CME credits.

Only sessions with completed attestations will appear on your certificate.

The ANCC CNE Credit Hour portal cannot be reopened after the deadline, per ANCC Accreditation Standards.
